### **2856, Guidelines for the Michigan Principal Residence**

1. Registered sellers who accept fully completed exemption certificates within 90 days subsequent to the date of sale are relieved of liability for the collection and payment of sales tax on the transactions covered by the exemption certificate.

### **SALES TAX ELIGIBLE NONREGISTERED TAXPAYER REGISTRATION**

The Government announced on 2 November 2017 that it would legislate for a mandatory comprehensive credit reporting regime to come into effect by 1 July 2018, requiring the big four banks to participate fully in the credit reporting system.
